On the second attachment, just to clarify a few things, addressing this to Mr Marks.

Am I right to assume that you do not have any way to find out what you paid each employee in the aggregate, say, for the year 2009, aside from laboriously looking up each person? In other words, there is no place that total salaries, or, if you prefer, wages, paid out for the year, per person, are listed, say in a budget projection for a year? I don't want to belabour the point but, for example, Somervell County immediately had the compensation list for each employee, and I assume they had budgeted for that amount, listed as 2009 salaries per person. It may be that their numbers are based on their projection rather than end of the year reconciliation, but nonetheless, they have a breakdown to know what is paid per year per employee. You do not have anything similar aside from hourly rates and cannot know what you paid for salaries/wages in 2009 in totals per person?

On the 501a doctors. Glen Rose Medical Center, which was a dba for Glen Rose Medical Foundation, and is now a dba for Somervell County Hospital Authority does not and did not (in 2009) pay out bonuses to doctors who are listed as part of the Glen Rose Healthcare, Inc, which I understand is a 501a corporation?

Thank you for the clarification. I am not attempting to make laborious work for you or extra cost for me asking for yearly salary/wage information, which would be known for 2009 and am happy to come in to inspect records; looking forward to your answer.
