Sirs/Madam

On March 20, 2010, I did a public information request asking for Glen Rose Medical Center yearly salaries. My request was contested to the Attorney General's office, your reference # OR2010-07692. I received a cc reply on May 26, 2010 in which the AG's office indicated that GRMC must supply that information. I have attached to this fax a copy of the original request in which I asked, very clearly, for yearly salaries.

What I received back yesterday was a *rate* (see the attached page on this fax) which is meaningless unless I also know a number of other facts, such as whether the employees are hourly or part time or full time, how many hours they worked, how much vacation did they take, etc. In other words, although I asked for yearly salary, the information I got back is not only not what I asked for but is meaningless without a whole lot of other information. I assume that this rate was not sent back intentionally to obfuscate yearly salary information. I have requested that I receive yearly salary information but have not gotten any reply regarding this.

I would like my request to be fulfilled the way I asked it to be.

I am requesting the following items.

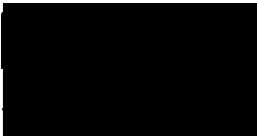
1. I would like a report listing of all bank account numbers, style (name) of each account, including the name of the bank and the current balance per the bank as of this date, as well as an explanation of the purpose of each account.

2. I would like a listing of yearly salaries/wages for all employees that are paid through either Somervell County or the Somervell County Hospital Authority dba Glen Rose Medical Center. In this listing, I would like the name of the person, his or her title and the yearly salary amount. If the doctors in the 501a corporation, Glen Rose Healthcare Inc received any funding from Somervell County in the months of January or February 2010, I would like those amounts included, along with the name of the doctor and date.

I would like these two report listing in electronic format, preferably sent back via email. If the cost of providing this is more than \$20, please contact me first.

I have included the open records form below, not signed, as I am sending this via email

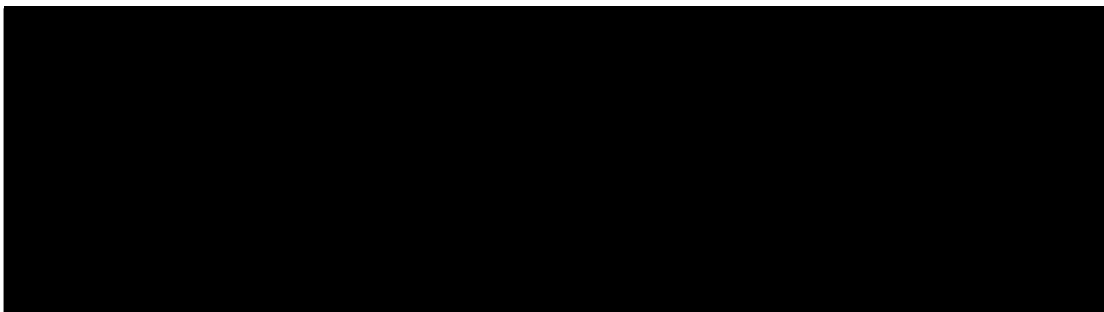
